## MCCLUSKY PUBLIC SCHOOL MCCLUSKY, ND 58463 UNOFFICIAL MINUTES REGULAR MEETING

The regular meeting of the McClusky Board of Education was held on July 30, 2018 in the High School Home Ec Room. Present were: Directors Larson, Strobel, Boehm (via telephone), Sease, and Hunt, Superintendent Ekstrom, Business Manager Lauer, and Reporter Allan Tinker.

President Larson called the meeting to order at 6:32 P.M.

Sease moved to approve the agenda with the addition of "Approval of the 2018-19 Math Contract", the unofficial minutes of the June 19, 2018 meeting, the bills for payment, and the financial report. Hunt seconded. Motion carried 5-0.

Reports were given by Superintendent Ekstrom, Principal Beck, and the Finance & Facilities Committee.

Unfinished Business: 1) Strobel moved to approve the final reading of policies ACBE, ACBE-AR, ACBE-BR, ACBE-E, CAAA-E, DEBG, DKA, DKA-E, DKBB, FFI-E, HBAA-E, HCAA, KAAA, KAB-E, KACB-E3 and KADA. Boehm seconded. Motion carried 5-0.

Reorganization of the Board: 1) Strobel moved to elect Larson for President. Hunt seconded. Vote carried 5-0 for Brian Larson as President. 2) Hunt moved to elect Strobel for Vice President. Sease seconded. Vote carried 5-0 for Heidi Strobel as Vice President. 3a) Larson and Strobel volunteered as Sports Co-op Committee Members. There were no other volunteers. 3b) Hunt and Rath volunteered as Negotiations Committee Members. There were no other volunteers. 3c) Rath and Hunt volunteered as School Board Policy Review Committee Members. There were no other volunteers. 3d) Sease and Larson volunteered as Finance & Facilities Committee Members. There were no other volunteers. 3e) Strobel and Sease volunteered as Wellness Committee Members. There were no other volunteered as the MREC Representative. There were no other volunteers. Strobel moved to approve the committee appointments. Hunt seconded. Motion carried 5-0.

The meeting moved forward with the new Board with former Director Boehm leaving the meeting and new Director Rath present.

Consent Agenda: 1a) To designate the second Tuesday of each month at 8:00 P.M. and 7:30 P.M. after Daylight Savings Time ends as the regular board meeting dates and times; 1b) To designate the McClusky Gazette as the official newspaper; 1c) To designate Lonetree Special Education Unit to be the special education unit; 2) To designate Superintendent Dale Ekstrom as the representative of all Federal Programs, including Title I, Title IIa, E-rate and REAP; 3a) To designate Superintendent Dale Ekstrom as the Authorized Hot Lunch Representative and to accept the income eligibility guidelines for free and reduced meals; 3b) To designate Board President Brian Larson as the Hearing Official; 4a) To keep Drivers Ed fees at \$100.00 for McClusky students and \$150.00 for out-of-district students; 4b) To keep sports fees at \$40.00 per sport and \$150.00 maximum per family; 4c) To price out Hot Lunch and Breakfast as follows: \$2.55 for elementary students, \$2.80 for high school students and guest students, \$3.45 for staff, \$3.55 for adult guests, \$1.55 for all student breakfasts, \$1.85 for staff and adult guest breakfasts and \$0.25 for milk; 5) To keep school board salaries at \$125.00 for regular meetings, \$50.00 for committee meetings and \$50.00 for special meetings; 6a) To increase substitute teacher pay to \$120.00 per day, plus free lunch; 6b) To keep the Stipend Pay at \$25.00 per hour; 7) To approve the School District's 2018-19 Organizational Memberships, to include North Dakota School Boards Association (NDSBA), North Dakota High School Activities Association (NDHSAA), North Dakota Small Organized Schools

(NDSOS), North Central Distance Learning Consortium (NCDLC), Missouri River Educational Co-operative (MREC), Missouri River Area Career & Technical Consortium (MRACTC), North Dakota Educators Service Co-operative (NDESC), Central McLean Athletic Co-op, Turtle Lake-Mercer-McClusky Athletic Co-op. Strobel moved to approve the above as a whole. Rath seconded. Motion carried 5-0.

New Business: 1) Hunt moved to table the 2018-2021 Technology Plan & Budget until quotes for the wireless system are received. Strobel seconded. Motion carried 5-0. 2) Strobel moved to approve the changes to the 2018-2019 school calendar. Sease seconded. Motion carried 5-0. 3) Instructional plans for Elementary classes were discussed. 4) Sease moved to approve the contract for Larry Clark for High School Math Teacher for the 2018-2019 school year. Rath seconded. Discussion was had. Motion carried 5-0. 5) The Miscellaneous Levy was discussed. 6) Housing for Teachers and Administrators was discussed. 6) The 2017-2018 Preliminary Financial Report was reviewed. 7) Hunt moved to approve the 2018-2019 preliminary budget and levying at 60 mills (\$382,000) for the General Fund, 3 mills (\$20,000) for the Special Reserve Fund and 10 mills (65,000) for the Building Fund. Sease seconded. Motion carried 5-0.

The next School Board Meeting will be Tuesday, August 14, 2018 at 8:00 P.M.

Sease moved to adjourn. Strobel seconded. Motion carried 5-0.
