The regular meeting of the McClusky Board of Education was held on July 30, 2019 in the High School Home Ec Room. Present were: Directors Larson, Strobel, Hunt, Sease, and Rath, Superintendent Ekstrom, Business Manager Lauer, reporter Allan Tinker, and guest Linda Bowers.

President Larson called the meeting to order at 7:01 P.M.

Rath moved to approve the agenda, the unofficial minutes of the July 12, 2019, June 25, 2019, June 18, 2019 and June 11, 2019 meetings, the bills for payment, and the financial report. Sease seconded. Motion carried 5-0.

A report was given by Superintendent Ekstrom.

There was no Old Business for the July meeting.

Reorganization of the Board: 1) Sease nominated Larson for President. Vote carried 5-0 for Brian Larson as President. 2) Hunt nominated Strobel for Vice President. Vote carried 5-0 for Heidi Strobel as Vice President. 3) Committee Members will be decided at the August Board Meeting.

Consent Agenda: 1a) To designate the second Tuesday of each month at 8:00 P.M. and 7:30 P.M. after Daylight Savings Time ends as the regular board meeting dates and times; 1b) To designate the McClusky Gazette as the official newspaper; 1c) To designate Lonetree Special Education Unit to be the special education unit; 2) To designate the Superintendent as the representative of all Federal Programs, including Title I, Title IIa, and REAP, and the Superintendent and Business Manager as the representatives of E-rate; 3a) To designate the Superintendent as the Authorized Hot Lunch Representative and to accept the income eligibility guidelines for free and reduced meals; 3b) To designate the Board President as the Hearing Official; 4a) To keep Drivers Ed fees at \$100.00 for McClusky students and \$150.00 for out-of-district students; 4b) To keep sports fees at \$40.00 per sport and \$150.00 maximum per family; 4c) To price out Hot Lunch and Breakfast as follows: \$2.65 for elementary students, \$2.90 for high school students and guest students, \$3.55 for staff, \$3.65 for adult guests, \$1.65 for all student breakfasts, \$1.95 for staff and adult guest breakfasts and \$0.25 for milk; 5) To keep school board salaries at \$125.00 for regular meetings, \$50.00 for committee meetings and \$50.00 for special meetings; 6a) To increase substitute teacher pay to \$120.00 per day, plus free lunch; 6b) To keep the Stipend Pay at \$25.00 per hour; 7) To approve the School District's 2019-20 Organizational Memberships, to include North Dakota School Boards Association (NDSBA), North Dakota High School Activities Association (NDHSAA), North Dakota Small Organized Schools (NDSOS), North Central Distance Learning Consortium (NCDLC), Missouri River Educational Co-operative (MREC), Missouri River Area Career & Technical Consortium (MRACTC), North Dakota Educators Service Co-operative (NDESC), Central McLean Athletic Co-op, Turtle Lake-Mercer-McClusky Athletic Co-op. Hunt moved to approve the above as a whole. Strobel seconded. Motion carried 5-0.

New Business: 1) Strobel moved to approve the agreement with Central Dakota Distance Learning Consortium. Sease seconded. Motion carried 5-0. 2) The 2019-20 enrollment numbers and instructional coverage plans were discussed. 3) The Miscellaneous Levy was discussed. 4) Rath moved to transfer \$5,200.00 from the Special Reserve Fund to the General Fund. Strobel seconded. Motion carried 5-0. 5) The preliminary 2019-2020 revenue and expenditure budgets were reviewed.

The next School Board Meeting will be Tuesday, August 13, 2019 at 8:00 P.M. The Facilities and Finance Committee will meet on Monday, August 12, 2019 at 12:00 P.M.

Sease moved to adjourn. Strobel seconded. Motion carried 5-0. The meeting adjourned at 7:58 P.M.
